**Extensive 8-Week Proposal Writing Course.** The Mayor's Office of Partnerships and Grant Services (OPGS) has partnered with The Magi Group, LLC to offer a proposal writing course for District of Columbia Government Employees and Nonprofit Executive Directors, Program Officers, Board of Directors and staff development officers. Participating nonprofit organizations must have programs that have been operating for at least one year. (There will be site visits to all nonprofit programs before selections). *Consultants and contractual staff working for nonprofits are not eligible.* Because of the popularity of the course only one person from each nonprofit will be allowed to participate. This course is designed for both the novice and the experienced individual. Course combines expert instruction, with practical exercises, to take you step-by-step through all the stages of planning programs, locating funding sources, and writing grant proposals. The class is limited and participants will be accepted via registration on a competitive basis. Class fees will be covered by a competitive scholarship, so it is important that all participants are able to commit to attend all sessions. Deadline to submit a registration is March 18. **The OMB Super Circular - Rules for Organizations Receiving Government Grants.** The D.C. Bar Pro Bono Center is hosting training about the "Rules for Organizations Receiving Government Grants" on Wednesday, February 24, 9:00 a.m.-11:00 a.m. at the Center for Nonprofit Advancement, 1666 K Street NW, Suite 440. If your nonprofit organization receives a government grant, you must comply with the OMB omnibus circular (the so-called "Super Circular") which outlines the requirements for the use and administration of federal grant funds given to nonprofit organizations, including cost principles for nonprofit organizations and the audit requirements. Specifically, the Super Circular governs the payment of indirect costs, procurement standards, and the documentation of compensation expenses. These rules will also apply to any D.C. grants that are funded in whole or in part by federal funds, and will also apply to any sub-grantees of those funds. Find out what the rules are and how they will apply to your organization. The training is free and a continental breakfast will be served. To register visit OMB Super Circular .

Secretary's Award for Public-Philanthropic Partnerships. **Can I Wear This? Balancing Personal Appearance Policies and the Law.** The D.C. Bar Pro Bono Center is sponsoring a free webinar as part of its **Board Basics Series**, entitled: *Can I Wear This? Balancing Personal Appearance Policies and the Law.* For many nonprofits, adopting a personal appearance policy can be an effective way to ensure that employees present a professional image to clients, donors and nonprofit partners. However, before drafting a policy, you should be aware of legal restrictions on employers' regulation of workplace attire and personal grooming. For example: Can you require a male employee to be clean shaven if he wears a beard for religious reasons? May an employee who is active in the union movement and wears a pro-union hat to work every day be required to comply with a no-hat policy? While federal and state laws generally allow employers to regulate employee appearance, a written policy will not protect employers against claims that the policy infringes on other rights protected by law. Two new resources from the D.C. Bar Pro Bono Center provide the answers to the questions above, and many others. The webinar will provide an important overview of the key D.C. and federal laws governing such policies and includes guidelines for drafting a policy.
