The seminar will look at the legal differences between an employee and a volunteer and offer information to help nonprofits clarify the volunteer relationship. The seminar will also discuss the legal issues involved in compensating a volunteer or reimbursing the volunteer's expenses—including whether such payments are subject to tax, how the nonprofit can avoid inadvertent problems under the wage and hour laws, and whether a volunteer can claim a tax deduction in connection with volunteering. It will also examine when a nonprofit can be held liable for a volunteer's actions, when a nonprofit may be liable to the volunteer, and ways to mitigate that liability. The session is designed for executive directors, board members, human resource professionals, and volunteer managers. The seminar is free and will be held on Thursday, November 12, 2015 from 11:30 a.m. to 3:45 p.m. at the offices of DLA Piper, 500 8th Street, NW, near Gallery Place Metro. A luncheon will be served.
