**Pepco Waterfront Substation**: **Call to Artists**. The DC Commission on the Art and Humanities (DCCAH) in partnership with Potomac Electric Power Company (Pepco) is seeking artists or artist teams for the design, fabrication and installation of a permanent work of public art for the new Pepco electrical substation coming to the Buzzard Point area in Southwest Washington, DC. Up to five semi-finalists will be selected to create site specific concept proposals. Each artist/artist team will be paid a \$2,000 design proposal stipend. The total project budget for the selected commission is \$250,000. This opportunity is open to all professional artists and teams residing in the United States. The proposed artwork will be sited at the corner plaza area at 1st and R Streets, SW providing a 20 x 20sf footprint. The design and artwork fabrication/installation budget is \$250,000, which must include artist design fees (no more than 20% of the project budget), and costs associated with design, fabrication, transportation, shipping, installation, insurance, engineered drawings (stamped by a DC licensed engineer), permits and photo documentation of the artwork. Each Semi-Finalist will be awarded a \$2,000 honorarium to create a site-
