The DC Bar Pro Bono Program is hosting a "Free Nonprofit Legal Clinic: Understanding the Building Blocks of Good Governance" on June 16 from 11 a.m. to 12:30 p.m. As you know, good governance policies are a critical part of every nonprofit's foundation, which is why the IRS Form 990 asks all Sec. 501(c)(3) organizations to indicate whether they have conflict-of-interest, whistleblower and record retention policies. At this clinic, you will meet one-on-one with an attorney who will help review and update your nonprofit's whistleblower and record retention policies and your conflict-of-interest policy and disclosure form. The attorney will also discuss with you the reasons the policies say what they do, and how best to implement them. Finally, the attorney will discuss with you some actions you can take now, so you know how to handle issues when they come up.
