W-2 Fraud – A Privacy Risk for Employees and Nonprofits Webinar. The DC Pro Bono Center is hosting a free webinar on W-2 Fraud – A Privacy Risk for Employees and Nonprofits Webinar, Friday, March 2 from 12 to 1 p.m. Every year around this time, employers and their Human Resources (HR) professionals are duped into sending W-2s to cyber thieves who then use the information to attempt to fraudulently file tax returns and claim refunds. Fraudsters bypass all the security devices, firewalls, perimeter defenses, and even APT defenses, and increasingly, cyber thieves are targeting nonprofits to hand over the goods. - and they do. HR or finance staff don't realize that the email requesting the W-2s is not from the Executive Director because the email may appear to be legitimate. The topics that will be discussed are: the common signatures of such attacks; ways to alert and train employees to lower the risk of a successful attack; how such cases are handled by the IRS; and related cases that indicate losses may not be covered by cybersecurity insurance.
