Free Nonprofit Legal Clinic: Understanding the Building Blocks of Good Governance. The D.C. Bar Pro Bono Center is sponsoring a free legal clinic on conflict-of-interest, whistleblower and record retention policies on June 21 from 10:30 am to 12:30 noon. The clinic will be held at Morrison & Foerster, 2000 Pennsylvania Avenue NW. The IRS has requirements regarding conflicts of interest and public disclosure of your tax filings, while the D.C. Nonprofit Code requires a nonprofit to maintain certain corporate records. Often, a Board adopts the policies, attaches them to the meeting minutes, and forgets about them. While all Sec. 501(c)(3) organizations should have well-drafted conflict of interest, record retention and whistleblower policies, it is just as important that organizations educate their directors, employees and volunteers about the policies and develop a plan to implement them. At this clinic, you will meet one-on-one with an attorney who will help review and update your nonprofit's whistleblower and record retention policies and your conflict of interest policy and disclosure form. The attorney will also discuss with you the reasons the policies say what they do, and how best to implement them.
