Grant funds may be used to fund the production of print, radio, or television ads; to pay for advertising space or airtime; or to produce or distribute pamphlets, books, videos, or press packets. To be eligible, applicants must be recognized as tax-exempt under Section 501(c) (3) of the United States Internal Revenue Code. The deadline to submit an application is December 15, 2018.
