The Center for Juvenile Justice Reform (CJJR), in partnership with the Office of Juvenile Justice and Delinquency Prevention's Center for Coordinated Assistance to States (CCAS), has issued a request for applications from jurisdictions seeking to engage in multi-system improvement efforts. The Multi-System Collaboration Training and Technical Assistance Program (additional information) supports jurisdictions that are interested in developing or enhancing a sound infrastructure to promote multi-system approaches to serving at-risk, justice-involved youth and their families.
