Fourth Quarter Report on Donations Approved by OPGD for FY 2005

Pursuant to Mayor's Order 2002-2 dated January 11, 2002, the Director of the Office of Partnerships and Grants Development (OPGD), in consultation with the D.C. Government Ethics Counselor, is publishing the District's First Quarter Report on Donations for Fiscal Year 2005. The Order requires the OPGD Director to review all requests by District officials to solicit or accept donations and approve or disapprove such requests as appropriate in accordance with the Rules of Conduct Governing Donations (Mayor Memorandum 2002-1) and Section 115 of the 2003 D.C. Appropriations Act. This report includes data on all donations requests submitted to the OPGD Director for the period beginning July 1, 2005 and ending September 30, 2005. During this period, the OPGD Director approved the solicitation and/or acceptance of \$645,963.16 in donations of which \$418,168.50 represented financial contributions and \$227,794.66 were in-kind donations.
